Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 7 of the Indian Christian Marriage Act, 1872 empowers the Government to appoint Sub Registrars, who are Christians as Marriage Registrars specified with their local area of jurisdiction. Consequent to the transfer of the appointed Marriage Registrars, Government have decided to appoint Sub Registrars who are Christians as Marriage Registrars in various districts by amending the notification issued as G. O. (Rt.) No. 381/2015/Law dated 31st March, 2015 and published as S. R. O. No. 193/2015 in the Kerala Gazette Extraordinary No. 753 dated 31st March, 2015.

The notification is intended to achieve the above object.
